- 3. Specifying the unit in the position *) excludes the student's passive electoral right in elections to the Students' Parliament of the University of Warsaw in units other than the indicated one.
- 4. Specifying the field of study in the position **) excludes the student's passive electoral right in elections to a given Council of the Students' Union in other electoral districts than the one appropriate for the indicated field of study.
- 5. The exclusions specified in point 3. and 4. cease with the validation of the results of the elections in which the student stood as a candidate, but not earlier than on 30 November of the academic year of that candidacy.
